# Topic I: Adapt Statutes to current circumstances – add the term «geospatial» Thème I:

# Article 1

# Existing version:

The International Cartographic Association (ICA) has the following aims:

a) Advancing the study of cartographic or geographic information (GI) science issues. In particular it is concerned with the processing, storage and analysis of source material and the design, construction, reproduction and display techniques of maps and associated forms of graphic communications. To this end, co-operation with different branches of geodetic, geographic and other scientific research disciplines is desirable.

# EC recommendation:

The International Cartographic Association (ICA) has the following aims:

a) Advancing the study of cartographic, geospatial or geographic information (GI) science issues. In particular it is concerned with the processing, storage and analysis of source material and the design, construction, reproduction and display techniques of maps and associated forms of graphic communications. To this end, co-operation with different branches of geodetic, geographic and other scientific research disciplines is desirable.

#### Article 3. National representation and membership of the Association

#### Existing version:

Any nation which pursues a cartographic or GI science activity can be accepted as a member nation of the ICA provided that it agrees to participate financially in supporting the Association and in collaborating actively in its scientific and technical activities. Each nation can only be represented by one single organisation, which should preferably be the national society or committee for cartography or GI science or a national mapping agency/authority. Thus, a member nation is represented by a national member organisation such as one of these.

Each national member organisation agrees to send a report to each General Assembly on the cartographic, geospatial and GI science activities in the country during the previous four years.

## Article 24. Commissions, Working Groups and Task Forces

#### Existing version:

The General Assembly of Delegates may establish commissions for the execution of important cartographic and GI science tasks. The tenure of office of a Commission is limited to the period between two General Assemblies, but may be extended for another period by a vote at a General Assembly of Delegates.

The tenure of office of a Commission is limited to the period between two General Assemblies, but may be extended for another period by a vote at a General Assembly of Delegates.

## Article 27. Publications

#### Existing version:

All publications of the Association require the approval of the Executive Committee. The Executive Committee will arrange for the publication of a bulletin or newsletter concerning the activities of the Association and its member nations, and facilitate the publication of papers on cartography and GI science.

#### EC recommendation:

All publications of the Association require the approval of the Executive Committee. The Executive Committee will arrange for the publication of a bulletin or newsletter concerning the activities of the Association and its member nations, and facilitate the publication of papers on cartography, geospatial and GI science.

#### Article 30. Dissolution of Association

Existing version:

A decision to dissolve the Association is only valid with the consent of at least two-thirds of the member nations.

In the case of dissolution, the funds of the Association will be placed, by the General Assembly of Delegates or the Executive Committee, at the disposal of one or several international scientific organisations, whose aims are closely related to cartography or GI science.

#### EC recommendation:

A decision to dissolve the Association is only valid with the consent of at least two-thirds of the member nations.

In the case of dissolution, the funds of the Association will be placed, by the General Assembly of Delegates or the Executive Committee, at the disposal of one or several

international scientific organisations, whose aims are closely related to cartography, geospatial or GI science.

# By-law 5. Dissolution of Association

Existing version:

- a) For the purpose of affiliation as described in Article 3 the following categories shall apply:
  - (1) (International) Educational establishments

(2) National cartographic or GI science societies other than the national member organisation

(3) National scientific organisations and technical organisations

These include academic, research or technical institutes or other scientific or technical bodies, governmental or autonomous, that are users of cartographic data and are demonstrably devoted to the discipline of cartography and GI science to the satisfaction of the Executive Committee.

(4) Nationally operating private firms / companies

These include such organisations that are engaged in the development, production or manufacture of cartographic or allied equipment or products and are committed to supporting the interests of the discipline of cartography and GI science to the satisfaction of the Executive Committee.

(5) Internationally operating private firms / companies

These include such organisations that are engaged in the development, production or manufacture of cartographic or allied equipment or products and are committed to supporting the interests of the discipline of cartography and GI science to the satisfaction of the Executive Committee.

(6) UN bodies.

EC recommendation:

a) For the purpose of affiliation as described in Article 3 the following categories shall apply:

(1) (International) Educational establishments

(2) National cartographic, geospatial or GI science societies other than the national member organisation

(3) National scientific organisations and technical organisations

These include academic, research or technical institutes or other scientific or technical bodies, governmental or autonomous, that are users of cartographic data and are demonstrably devoted to the discipline of cartography and GI science to the satisfaction of the Executive Committee.

(4) Nationally operating private firms / companies

These include such organisations that are engaged in the development, production or manufacture of cartographic or allied equipment or products and are committed to supporting the interests of the discipline of cartography, geospatial and GI science to the satisfaction of the Executive Committee.

(5) Internationally operating private firms / companies

These include such organisations that are engaged in the development, production or manufacture of cartographic or allied equipment or products and are committed to

supporting the interests of the discipline of cartography, geospatial and GI science to the satisfaction of the Executive Committee. (6) UN bodies.

#### EC justification:

It is important that the ICA keep pace with new terms that expand the core fields of cartography and GIScience. The term «geospatial» gained prominence with significant attention to location information propelled by technology and data developments. To keep pace with advances on geospatial, the EC recommends adding the reference to «geospatial» in all articles where approproiate.

Topic II: Adopt a more current and precise definition of membership – «national member» and «country» to be replaced by «member state» in all articles Thème II:

#### Article 1

Existing version:

The International Cartographic Association (ICA) has the following aims:

b) Initiating, fostering and co-ordinating research in cartography and GI science, involving the co-operation between different nations, the exchange of ideas and documents, the furtherance of education and training in cartography and GI science, and encouraging the dissemination of cartographic and GI science knowledge.

#### Article 3. National representation and membership of the Association

#### Existing version:

...

Any nation which pursues a cartographic or GI science activity can be accepted as a member nation of the ICA provided that it agrees to participate financially in supporting the Association and in collaborating actively in its scientific and technical activities. Each nation can only be represented by one single organisation, which should preferably be the national society or committee for cartography or GI science or a national mapping agency/authority. Thus, a member nation is represented by a national member organisation such as one of these. Furthermore, the ICA can accept requests for affiliated membership from international or national scientific, technical or other organisations made for the purpose of collaborating in its activities, and without compromising the principle of single representation of each nation in the official functioning of the Association or affecting the methods of voting as described in Articles 4, 26 and By-Law 5. Application to become a member nation or affiliate member shall be made by letter to the Secretary General and Treasurer and may be approved by the Executive Committee subject to ratification at the next General Assembly of Delegates. Such new member may exercise their rights of membership, except voting, upon the approval from the Executive Committee in the interim period.

#### EC recommendation:

#### Article 3. Member stateNational representation and membership of the Association

Any statenation which pursues a cartographic or GI science activity can be accepted as a member statenation of the ICA provided that it agrees to participate financially in supporting the Association and in collaborating actively in its scientific and technical activities. Each member statenation can only be represented by one single organisation, which should preferably be the national society or committee for cartography or GI science or a national mapping agency/authority. Thus, a member statenation is represented by a national member state organisation such as one of these. Furthermore, the ICA can accept requests for affiliated membership from international regional or localnational scientific, technical or other organisations made for the purpose of collaborating in its activities, and without compromising the principle of single representation of each member statenation in the official functioning of the Association or affecting the methods of voting as described in Articles 4, 26 and By-Law 5. Application to become a member statenation or an affiliate member shall be made by letter to the Secretary General and Treasurer and may be approved by the Executive Committee subject to ratification at the next General Assembly of Delegates. Such new member may exercise their rights of membership, except voting, upon the approval from the Executive Committee in the interim period.

#### Article 4. Delegates and voting rights

#### Existing version:

Every member nation has the right to one vote in the General Assembly of Delegates. For this purpose, each member nation is represented at the General Assemblies of the

Association by a principal delegate and by a deputy, who may vote in the absence of the principal delegate. However, at the request of the Executive Committee, the General Assembly may withdraw the right to vote from member nations which have not paid their contribution for the previous three years.

## EC recommendation:

Every member statenation has the right to one vote in the General Assembly of Delegates. For this purpose, each member statenation is represented at the General Assemblies of the Association by a principal delegate and by a deputy, who may vote in the absence of the principal delegate. However, at the request of the Executive Committee, the General Assembly may withdraw the right to vote from a member statenation which has have not paid their contribution for the previous three years.

Every member statenation or affiliate member, either individually or in conjunction with one or more of the other member statesnations-or other affiliate members, can submit motions (see Article 10) to the Association which are appropriate to the Association for discussion.

Each national member state organisation prepares agrees to send a report to each General Assembly on the cartographic and GI science activities in their state country during the previous four years.

# Article 7. Composition of the General Assembly of Delegates

#### Existing version:

The General Assembly of Delegates is formed from the principal delegates of each national member organisation and their deputies, who are able to attend, and the members of the Executive Committee.

If the Executive Committee so permits, additional delegates may attend the General Assembly of Delegates as observers.

A member nation, which is represented on the Executive Committee, can nominate that committee member as its principal delegate with the right to vote.

Normally, the President of the Association will preside at the General Assembly.

## EC recommendation:

The General Assembly of Delegates is formed from the principal delegates of each <del>national</del> member state organisation and their deputies, who are able to attend, and the members of the Executive Committee.

If the Executive Committee so permits, additional delegates may attend the General Assembly of Delegates as observers.

A member statenation, which is represented on the Executive Committee, can nominate that committee member as its principal delegate with the right to vote.

Normally, the President of the Association will preside at the General Assembly.

## Article 9. Meetings of the General Assembly of Delegates

## Existing version:

In special circumstances, with the agreement of the Executive Committee, the President has the right to call an Extraordinary General Assembly. The President is also obliged to do so if one third of the member nations demand it.

In special circumstances, with the agreement of the Executive Committee, the President has the right to call an Extraordinary General Assembly. The President is also obliged to do so if one third of the member states nations demand it.

# Article 10. Agenda

#### Existing version:

The agenda of every General Assembly of Delegates is decided upon by the Executive Committee. It will be communicated to the representative of each member nation three months before the General Assembly of Delegates takes place.

In order to make this feasible, national member organisations, who want to bring an issue to the agenda, must propose a motion on that issue in writing to the Secretary General and Treasurer at least five months before the date of the General Assembly. See also By-Law 8. ...

# EC recommendation:

The agenda of every General Assembly of Delegates is decided upon by the Executive Committee. It will be communicated to the representative of each member state<del>nation</del> three months before the General Assembly of Delegates takes place.

In order to make this feasible, <del>national</del>-member states-organisations</del>, who want to bring an issue to the agenda, must propose a motion on that issue in writing to the Secretary General and Treasurer at least five months before the date of the General Assembly. See also By-Law 8.

# Article 11. Voting

# Existing version:

Voting by proxy will not be permitted and no delegate shall represent or vote for any other member nation.

Voting by correspondence will be permitted only in accordance with Articles 28 and 30.

#### EC recommendation:

Voting by proxy will not be permitted and no delegate shall represent or vote for any other member statenation.

Voting by correspondence will be permitted only in accordance with Articles 28 and 30.

# Article 13. Election of the Executive Committee

#### Existing version:

No member nation may have more than one representative on the Executive Committee.

In the event of a vacancy arising in the Executive Committee in the period between two General Assemblies, the Executive Committee, after consultation with the member nation which the person represented, will appoint a replacement from the same member nation to serve until the next General Assembly at which a new Executive Committee is elected. If a vacancy arises in the Presidency, an Acting President will be elected by the Executive Committee. The Secretary General and Treasurer shall organise the election as soon as possible following the vacancy.

# EC recommendation:

No member statenation may have more than one representative on the Executive Committee.

...

In the event of a vacancy arising in the Executive Committee in the period between two General Assemblies, the Executive Committee, after consultation with the member statenation which the person represented, will appoint a replacement from the same member statenation to serve until the next General Assembly at which a new Executive Committee is elected. If a vacancy arises in the Presidency, an Acting President will be elected by the Executive Committee. The Secretary General and Treasurer shall organise the election as soon as possible following the vacancy.

# Article 20. Payment of subscriptions

#### Existing version:

Each national member organisation and affiliate member is responsible for paying the annual subscription.

If a national member organisation has not paid its subscription for three consecutive years, the Executive Committee may decide that it shall be given observer status until payment is

made. If they refuse to pay they will cease to form part of the Association by a decision taken by the General Assembly of Delegates.

# EC recommendation:

Each national member stateorganisation and affiliate member is responsible for paying the annual subscription.

If a national-member stateorganisation has not paid its subscription for three consecutive years, the Executive Committee may decide that it shall be given observer status until payment is made. If they refuse to pay they will cease to form part of the Association by a decision taken by the General Assembly of Delegates.

# Article 22. International Cartographic Conferences

# Existing version:

International Cartographic Conferences (ICC) may be called by the Executive Committee independently of the regular General Assemblies of Delegates, but preferably they should, if possible, be co-ordinated with them regarding time and location (see Article 9). The General Assembly of Delegates entrusts, to one of the member nations, the organisation of an ICC. The host nation shall decide the programme subject to the approval of the Executive Committee.

# EC recommendation:

International Cartographic Conferences (ICC) may be called by the Executive Committee independently of the regular General Assemblies of Delegates, but preferably they should, if possible, be co-ordinated with them regarding time and location (see Article 9). The General Assembly of Delegates entrusts, to one of the member states<del>nations</del>, the organisation of an ICC. The host <del>nation</del>-shall decide the programme subject to the approval of the Executive Committee.

# Article 25. Invitation of additional persons as observers

# Existing version:

The President of the Association is entitled to invite to General Assemblies, International Cartographic Conferences, Symposia or Joint Meetings, suitable additional persons as observers or guests, including persons who are not from a member nation of the ICA.

# EC recommendation:

The President of the Association is entitled to invite to General Assemblies, International Cartographic Conferences, Symposia or Joint Meetings, suitable additional persons as observers or guests, including persons who are not from a member statenation of the ICA.

# Article 27. Publications

# Existing version:

All publications of the Association require the approval of the Executive Committee. The Executive Committee will arrange for the publication of a bulletin or newsletter concerning

the activities of the Association and its member nations, and facilitate the publication of papers on cartography and GI science.

# By-law 5

# By-law 7

## Existing version:

All national and affiliate members may propose representatives for each commission for consideration by the chairperson of that commission.

# EC recommendation:

All member states national and affiliate members may propose representatives for each commission for consideration by the chairperson of that commission.

## By-law 8

## Existing version:

Nominations for President, Secretary General and Treasurer, and Vice-President of the Executive Committee, and nominations of chairpersons of commissions, duly proposed by their respective member nations, must be received by the Secretary General at least five months prior to the date determined for the General Assembly of Delegates. Such nominations must be accompanied by an indication in writing from the candidate that he/she is willing to serve, supported by a brief CV.

# EC recommendation:

Nominations for President, Secretary General and Treasurer, and Vice-President of the Executive Committee, and nominations of chairpersons of commissions, duly proposed by their respective member statesnations, must be received by the Secretary General at least five months prior to the date determined for the General Assembly of Delegates. Such nominations must be accompanied by an indication in writing from the candidate that he/she is willing to serve, supported by a brief CV.

#### By-law 9

#### Existing version:

In order to ensure that the commission is fulfilling their approved terms of reference, the Executive Committee, as a last resort, may take appropriate action: recommend that the nominating country replace the commission chairperson; refuse access to funding; remove them from the listings of current commissions; and remove ICA endorsement for their activities.

# EC recommendation:

In order to ensure that the commission is fulfilling their approved terms of reference, the Executive Committee, as a last resort, may take appropriate action: recommend that the nominating member statecountry replace the commission chairperson; refuse access to funding; remove them from the listings of current commissions; and remove ICA endorsement for their activities.

#### EC justification:

There were inconsistencies in reference to identifying a member of the ICA throughout the statutes and by-laws. Words like country, nation, national member and others were used interchangeably and led to confusion and inaccuracies. Furthermore, some terms are not clearly defined internationally and leave room for interpretation, e.g. «nation». Aligning with the way the United Nations refers to its members as «Member State» was recommended by the EC to improve clarity.

Remarks by the ICA Statutes Committee:

Fully supported. The best terminology appropriate to ICA amongst the notions of «country», «nation» and «state» was discussed. The EC and Statutes Committee agrees on «member state» as the best and most appropriate term for use within ICA, according to the use in other Associations and the United Nations.

The ICA subscribes to the 1958 declaration of the 8th General Assembly of the International Council for Science (ICSU) concerning non-discrimination on the basis of politics, nationality, religion, race or gender.

# EC recommendation:

The ICA subscribes to the <del>1958</del> declaration of the 8th General Assembly of the International Council for Science (ICSU) concerning non-discrimination on the basis of politics, nationality, religion, race or gender. Principles of Freedom and Responsibility in Science of the International Science Council, which «promotes equitable opportunities for access to science and its benefits, and opposes discrimination based on such factors as ethnic origin, religion, citizenship, language, political or other opinion, sex, gender identity, sexual orientation, disability or age.» (Art. 7 of the ISC Statutes) EC justification:

In July 2018, the International Council for Science merged with the International Social Science Council to form the International Science Council (ISC). As a result, the ISC has adopted new statutes. This modification reflects also the current ISC position on non-discrimination in which the ICA is a member organisation.

Any nation which pursues a cartographic or GI science activity can be accepted as a member nation of the ICA provided that it agrees to participate financially in supporting the Association and in collaborating actively in its scientific and technical activities. Each nation can only be represented by one single organisation, which should preferably be the national society or committee for cartography or GI science or a national mapping agency/authority. Thus, a member nation is represented by a national member organisation such as one of these. Furthermore, the ICA can accept requests for affiliated membership from international or national scientific, technical or other organisations made for the purpose of collaborating in its activities, and without compromising the principle of single representation of each nation in the official functioning of the Association or affecting the methods of voting as described in Articles 4, 26 and By-Law 5. Application to become a member nation or affiliate member shall be made by letter to the Secretary General and Treasurer and may be approved by the Executive Committee subject to ratification at the next General Assembly of Delegates. Such new member may exercise their rights of

membership, except voting, upon the approval from the Executive Committee in the interim period.

# EC recommendation:

Any nation which pursues a cartographic or GI science activity can be accepted as a member nation of the ICA provided that it agrees to participate financially in supporting the Association, and in collaborating collaborates actively in its scientific and technical activities, and fully accepts and supports in all its activities the ICA aims and codes of conduct as specified in Article 1 and other corresponding ICA guidelines. Each nation can only be represented by one single organisation, which should preferably be the national society or committee for cartography or GI science or a national mapping agency/authority. Thus, a member nation is represented by a national member organisation such as one of these. Furthermore, the ICA can accept requests for affiliated membership from international or national scientific, technical or other organisations made for the purpose of collaborating in its activities, and without compromising the principle of single representation of each nation in the official functioning of the Association or affecting the methods of voting as described in Articles 4, 26 and By-Law 5. Application to become a member nation or affiliate member shall be made by letter to the Secretary General and Treasurer and may be approved by the Executive Committee subject to ratification at the next General Assembly of Delegates. Such new member may exercise their rights of membership, except voting, upon the approval from the Executive Committee in the interim period.

# Article 4. Delegates and voting rights

# Existing version:

Every member nation has the right to one vote in the General Assembly of Delegates. For this purpose, each member nation is represented at the General Assemblies of the Association by a principal delegate and by a deputy, who may vote in the absence of the principal delegate. However, at the request of the Executive Committee, the General Assembly may withdraw the right to vote from member nations which have not paid their contribution for the previous three years.

# EC recommendation:

Every member nation has the right to one vote in the General Assembly of Delegates. For this purpose, each member nation is represented at the General Assemblies of the Association by a principal delegate and by a deputy, who may vote in the absence of the principal delegate. However, at the request of the Executive Committee, the General Assembly may withdraw the right to vote from member nations which have not paid their contribution for the previous three years who have failed to fulfill one or all of its obligations in accordance with its membership in the Association as given in Article 3.

# Article 8. Authority of the General Assembly of Delegates

# Existing version:

The General Assembly of Delegates

• decides on the policy and Statutes and By-Laws of the Association.

- ratifies the membership of new members, which have been considered and approved by the Executive Committee.
- elects the President, the Secretary General and Treasurer, the Vice-Presidents and two auditors.
- receives the reports of the Executive Committee and the Commissions and Working Groups for the previous period of office.
- decides on the budget and the resources available for the following (four-year) period.
- determines the programme of activities in general and decides, in principle, on planned activities or meetings, including the next meeting of the General Assembly.

## EC recommendation:

The General Assembly of Delegates

- establishes Commissions, elects the chairpersons of Commissions and approves the terms of reference, subject to the provisions of Article 24.

# EC justification:

The ICA statutes have no provision for relinquishing membership other than for arrears in paying dues. Other international professional societies have statute provisions that authorise the Association to take action on any member that does not abide by the organisation's aims or code of conduct. The proposed language addresses this omission and allows for the General Assembly to take necessary steps. In addition, it clarifies the process if a member actively wants to leave ICA, even if they have paid their dues to date. This was not previously specified.

Remarks by the ICA Statutes Committee:

Fully supported. With amendments to the suggested wording.

If a member state or affiliate member wishes to leave ICA, the membership fee for the year in which it expresses its intention to leave the Association is due. The final decision is taken by the General Assembly, according to Art. 8.

If a national member organisation has not paid its subscription for three consecutive years, the Executive Committee may decide that it shall be given observer status until payment is made. If they fail or refuse to payrefuse to pay until the following General Assembly, they will cease to form part of the Association by a decision taken by the General Assembly of Delegates.

If an affiliate member organisation has not paid its subscription for three consecutive years, they will cease to form part of the Association by a decision taken by the General Assembly of Delegates.

# EC justification:

The procedure for suspending or terminating membership is not specified in the statutes. This omission can lead to inconsistent interpretation for invoking a suspension or termination. The EC proposes language to clearly state the procedures for consistency and clarity. <u>Remarks by the ICA Statutes Committee:</u> Fully supported. With amendments to the suggested wording.

Topic VII: Organisational aspects – extraordinary General Assembly (currently not clearly regulated)

Thème VII:

#### Article 9. Meetings of the General Assembly of Delegates

Existing version:

The General Assembly of Delegates will normally meet every four years.

At each General Assembly the time and place of the next meeting will be decided or, if this is impractical, the decision will be made by the Executive Committee.

In special circumstances, with the agreement of the Executive Committee, the President has the right to call an Extraordinary General Assembly. The President is also obliged to do so if one third of the member nations demand it.

As a rule, the General Assembly will be held in conjunction with an International Cartographic Conference (ICC).

EC recommendation:

The General Assembly of Delegates will normally meet every four years.

At each General Assembly the time and place of the next meeting will be decided or, if this is impractical, the decision will be made by the Executive Committee.

In special circumstances, with the agreement of the Executive Committee, the President has the right to call an Extraordinary General Assembly. The President is also obliged to do so if one third of the member nations demand it.

As a rule, the General Assembly will be held in conjunction with an International Cartographic Conference (ICC).

Extraordinary General Assemblies may also be held in conjunction with Regional Cartographic or other conferences. The President takes the final decision on the location.

## Article 10. Agenda

#### Existing version:

The agenda of every General Assembly of Delegates is decided upon by the Executive Committee. It will be communicated to the representative of each member nation three months before the General Assembly of Delegates takes place.

In order to make this feasible, national member organisations, who want to bring an issue to the agenda, must propose a motion on that issue in writing to the Secretary General and Treasurer at least five months before the date of the General Assembly. See also By-Law 8. Motions not listed on the agenda cannot be brought to that Assembly for a decision. However, the President is entitled to accept such motions, but for discussion only.

## EC recommendation:

The agenda of every General Assembly of Delegates is decided upon by the Executive Committee. In the case of an ordinary General Assembly, it will be communicated to the representative of each member nation three months before the General Assembly of Delegates takes place. For an Extraordinary General Assembly a deadline of one month applies.

In order to make this feasible, national member organisations, who want to bring an issue to the agenda of an ordinary General Assembly, must propose a motion on that issue in writing to the Secretary General and Treasurer at least five months before the date of the General Assembly. See also By-Law 8.

Motions not listed on the agenda cannot be brought to that Assembly for a decision. However, the President is entitled to accept such motions, but for discussion only.

#### EC justification:

For an Extraordinary General Assembly, turn out by representatives of a Member State is more likely when aligned with an ICC or another regional cartographic or related conference. More latitude in aligning an Extraordinary General Assembly with an existing event increases attendance for the special meeting.

An Extraordinary General Assembly is called for a special purpose such as one or more very important timely decisions to be decided by the body or a special topic that needs attention prior to the timing of the next General Assembly. As these are limited special issues with impending timing, less advance time is offered or needed to prepare for a very limited agenda.

Fully supported. With amendments to the wording.

#### Article 3. National representation and membership of the Association

Existing version:

Application to become a member nation or affiliate member shall be made by letter to the Secretary General and Treasurer and may be approved by the Executive Committee subject to ratification at the next General Assembly of Delegates. Such new member may exercise their rights of membership, except voting, upon the approval from the Executive Committee in the interim period.

#### EC recommendation:

Application to become a member nation or affiliate member shall be made by writingletter to the Secretary General and Treasurer and may be approved by the Executive Committee subject to ratification at the next General Assembly of Delegates. Such new member may exercise their rights of membership, except voting, upon the approval from the Executive Committee in the interim period.

# Article 11. Voting

Existing version:

Decisions at the General Assembly shall be taken by a show of hands and by a simple majority vote, of those delegates present, who have the right to vote.

However, if at least two delegates, or the Executive Committee, make a request, the vote shall be taken by ballot. Should there be an equal division of vote, the President shall cast the deciding vote.

Voting by proxy will not be permitted and no delegate shall represent or vote for any other member nation.

Voting by correspondence will be permitted only in accordance with Articles 28 and 30.

#### EC recommendation:

Decisions at the General Assembly shall be taken by a show of hands and by a simple majority vote, of those delegates present, who have the right to vote.

However, if at least two delegates, or the Executive Committee, make a request, the vote shall be taken by ballot. Should there be an equal division of vote, the President shall cast the deciding vote.

Voting by proxy will not be permitted and no delegate shall represent or vote for any other member nation.

Voting by correspondence will be permitted only in accordance with Articles 28 and 30.

#### Article 28. Changes in the statutes

Existing version:

Motions concerning changes in the Statutes must be received in writing by the Executive Committee at least five months before the General Assembly of Delegates.

Provided this is done, the Executive Committee must present to the General Assembly any motion for changes in Statutes and include the motion on the agenda for the General Assembly (see also Article 10).

The Executive Committee may itself propose motions for changes in the Statutes and the adoption, modification or rescinding of By-Laws to be included on the agenda for the General Assembly of Delegates. The Executive Committee may establish a Committee on Statutes and By-Laws for advice.

In order for a motion to be accepted, an absolute majority of the voting member nations of the Association is necessary, voting in person or by correspondence.

For votes on changes to the Statutes, a member nation, not represented at a General Assembly, may forward its vote to the President of the Association by letter. For such a vote to be valid it must be received by the Secretary General ten days before the motion is presented to the General Assembly of Delegates.

Changes in Statutes are effective immediately after the General Assembly at which they are adopted.

#### EC recommendation:

Motions concerning changes in the Statutes must be received in writing by the Executive Committee at least five months before the General Assembly of Delegates.

Provided this is done, the Executive Committee must present to the General Assembly any motion for changes in Statutes and include the motion on the agenda for the General Assembly (see also Article 10).

The Executive Committee may itself propose motions for changes in the Statutes and the adoption, modification or rescinding of By-Laws to be included on the agenda for the General Assembly of Delegates. The Executive Committee may establish a Committee on Statutes and By-Laws for advice.

In order for a motion to be accepted, an absolute majority of the voting member nations of the Association is necessary<del>, voting in person or by correspondence</del>.

For votes on changes to the Statutes, a member nation, not represented at a General Assembly, may forward its vote to the President of the Association by letter. For such a vote to be valid it must be received by the Secretary General ten days before the motion is presented to the General Assembly of Delegates.

Changes in Statutes are effective immediately after the General Assembly at which they are adopted.

## Article 29. By-laws

## Existing version:

Within the framework of these Statutes, the General Assembly of Delegates shall have the power to adopt By-Laws. These may be adopted, modified or rescinded by a simple majority of votes expressed by the principle delegates attending the General Assembly. Changes in By-Laws take effect immediately after the General Assembly at which they are adopted.

# EC recommendation:

Within the framework of these Statutes, the General Assembly of Delegates shall have the power to adopt By-Laws. These may be adopted, modified or rescinded by a simple majority of votes expressed by the principale delegates attending the General Assembly. Changes in By-Laws take effect immediately after the General Assembly at which they are adopted.

# EC justification:

Article 3: Allows for communicating based on current norms and for facilitating to become an ICA member.

Article 11 on voting: Allows other, more modern methods of voting beyond a physical show of hands or written voting forms.

Article 28: The EC recommends a flexible approach, open to any future technologies and voting forms, for voting by eliminating references to voting in person or by correspondence. A delegate must be present to vote which could also be remote if agreed to by the General Assembly. As stated in the remarks section below by the ICA Statutes Committee, the EC left the options more open for decision by the General Assembly and the Executive Committee, in order not to change the definition too often in relation to current practices. Article 29: At the point where a change to a statute is accepted by the General Assembly, the change goes into effect immediately. This allows (not but forces) the ICA to respond more quickly to urgent motions and to implement decisions quickly when necessary – instead of waiting for the next General Assembly in only 4 years' time.

Remarks by the ICA Statutes Committee:

Fully supported. With amendments to the wording. The Statutes Committee went further and proposed to specify the future organisation and participation in the General as either «virtual or in-person». The EC did not follow this proposal and suggests a more generic and less strict formulation which leaves it open for future generations to organise the General Assembly in a way which is adequate to the then existing circumstances – without changing the Statutes in this point all the time.

#### Article 13. Election of the Executive Committee

Existing version:

No member nation may have more than one representative on the Executive Committee. The President, the Vice-Presidents and the Secretary General and Treasurer shall be elected by the General Assembly of Delegates and shall hold office until the end of the following General Assembly.

They can be re-elected, but with the following restrictions:

- the President may not serve for three consecutive terms.
- the Vice-Presidents and the Secretary General and Treasurer may not serve for three consecutive terms.

In the event of a vacancy arising in the Executive Committee in the period between two General Assemblies, the Executive Committee, after consultation with the member nation which the person represented, will appoint a replacement from the same member nation to serve until the next General Assembly at which a new Executive Committee is elected. If a vacancy arises in the Presidency, an Acting President will be elected by the Executive Committee. The Secretary General and Treasurer shall organise the election as soon as possible following the vacancy.

# EC recommendation:

No member nation may have more than one representative on the Executive Committee. The President, the Vice-Presidents and the Secretary General and Treasurer shall be elected by the General Assembly of Delegates and shall hold office until the end of the following General Assembly.

They can be re-elected, but with the following restrictions:

- the President-may not serve for three consecutive terms in the same position.
- the Vice-Presidents and the Secretary General and Treasurer may not serve for three consecutive terms.

In the event of a vacancy arising in the Executive Committee in the period between two General Assemblies, the Executive Committee, after consultation with the member nation which the person represented, will appoint a replacement from the same member nation to serve until the next General Assembly at which a new Executive Committee is elected. If a vacancy arises in the Presidency or in the Position of the Secretary General and Treasurer, an Acting President or an Acting Secretary General and Treasurer will be elected by the Executive Committee. The Secretary General and Treasurer or the President shall organise the election as soon as possible following the vacancy.

EC justification:

Wording changes are recommended to simplify the conditions of re-election and add a vacancy replacement procedure for the Secretary General and Treasurer, similar to that of President (which is currently not specified).

#### Article 15. Domicile of the Association

<u>Existing version:</u> The domicile of the Association is determined by the General Assembly.

EC recommendation:

The domicile of the Association is Switzerlanddetermined by the General Assembly.

#### EC justification:

Necessary clarification for ICA bank, Tax authorities and many member states. The ICA lost its banking arrangement in the Netherlands in 2020 – without pre-warning. Having the domicile, the banking function and the ICA Office in the same country is preferred and required by government laws in many countries. Without stating this clearly in the Statutes, the ICA is at risk of losing their bank account and tax status in Switzerland – without having any alternative. Currently, there is no proof of our domicile in any official document (neither in the Statutes, nor in the minutes of any General Assembly, as the GA never voted on this).

Banks, Authorities, but also an increasing number of members today demand an explicit mentioning of the location an address of the office and domicile of the Association, as for example membership payments cannot be made without these.

#### Article 16. Secretariat

Existing version:

A secretariat may be installed, either at the meeting place of the General Assembly of Delegates or at the domicile of the President or of the Secretary General and Treasurer. Such a secretariat may have paid employees, whose salaries are to be determined by the Secretary General and Treasurer with the approval of the Executive Committee.

EC recommendation: Article 16. SecretariatOffice

An office secretariat-may be installed, either at the domicile of the Associationmeeting place of the General Assembly of Delegates or at the domicile of the President or of the Secretary General and Treasurer. It reports to the Secretary General.

Such an office secretariat may have paid employees, whose salaries are to be determined by the Secretary General and Treasurer with the approval of the Executive Committee.

#### Article 19. Use of funds

#### Existing version:

The income of the Association is to be devoted to paying for:

- the cost of administration.
- travel costs within the limits decided by the President and / or the Secretary General and Treasurer.
- the remuneration of any paid staff in the office of the Secretary General and Treasurer.
- any purchase designed to achieve the general purposes of the Association as approved by the General Assembly.
- ICA Scholarships.

#### EC recommendation:

The income of the Association is to be devoted to paying for:

- the cost of administration.
- travel costs within the limits decided by the President and <del>/ or the Secretary General and Treasurer.</del>
- the remuneration of any paid staff in the ICA office-of the Secretary General and Treasurer.
- any purchase designed to achieve the general purposes of the Association as approved by the General Assembly.
- ICA Scholarships.

#### EC justification:

Article 16: Establishing an office with a location and address is a minimum requirement for increasingly complex international banking laws and company regulations which affect more and more membership payments (which can otherwise not be executed). During this last term, the ICA was in jeopardy of having no bank to conduct the fiducial responsibilities by the Secretary General and Treasurer on behalf of the ICA. With a documented domicile, an office location for the Association, that does not constantly change, and a banking arrangement in the same domicile collectively helps to assure sound arrangements to conduct the financial business of the ICA. Other Association have taken similar steps and long established offices at certain places.

Article 19: Wording changes on use of funds aligns with changes proposed for Article 16.
